



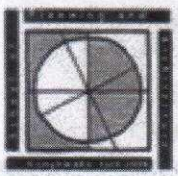
NOTICE

Eligibility List for Rolling PhD Admissions for July Session of A.Y 2026-27

1. All the 'eligible/provisionally eligible' applicants, as indicated in Annexure- I are eligible to appear for the Qualifying Entrance Examination (Stage I) related to the PhD Admission Process for Doctoral Programmes at SPA Vijayawada. The candidates, who qualify in Stage I, shall only appear for Stage II (Interview). All 'eligible/provisionally eligible' applicants as indicated in Annexure- I are required to report to the SPA Vijayawada campus by 10.00AM on 21st April, 2026.
2. Applicants indicated as 'eligible/provisionally eligible' require to produce necessary original documents and their copies as indicated in Annexure – I and get their applications verified between 10.00AM – 11.00AM on 21st April, 2026. Interviews in Stage II of admission process for such 'eligible/provisionally eligible' candidates will be started only upon clearance after verification is done and upon qualifying in the Qualifying Written Entrance Examination (Stage I).
3. All 'eligible/provisionally eligible' applicants are required to carry with them, all supporting originals documents (and one self-attested copies of the originals) related to their application in terms of educational background, marks for each semester, degree certificates, provisional degree certificates, valid caste and category certificates as per Central Govt. format, identity proofs, date of birth, NOC, portfolio etc, as per requirements of the application and advertisement.
4. Qualifying Entrance Examination (Stage I) will be held between 11.00 AM and 12.00 Noon on 21st April, 2026. For more details about exams and syllabi, you may see info, already available at <https://spav.ac.in/spavadmissions.html> and <https://spavadm.samarth.edu.in/index.php/>.
5. Candidates who have been qualified in Entrance Examination (Stage I) will be allowed to appear for Stage II {individual personal Interviews and research proposal (write up) and brief presentation (of research interest)}. Stage II will be held on 22nd April 2026 (starting at 10.00AM).
